

Privacy Policy:

Manchester Artists Association ("**Manchester Artists Association**") operates manchesterartists.com and may operate other websites. It is Manchester Artists Associations policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, Manchester Artists Association collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Manchester Artists Associations purpose in collecting non-personally identifying information is to better understand how Manchester Artists Associations visitors use its website. From time to time, Manchester Artists Association may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Manchester Artists Association also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on manchesterartists.com blogs/sites. Manchester Artists Association only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to Manchester Artists Associations websites choose to interact with Manchester Artists Association in ways that require Manchester Artists Association to gather personally-identifying information. The amount and type of information that Manchester Artists Association gathers depends on the nature of the interaction. For example, we ask visitors who sign up at manchesterartists.com to provide a username and email address. Those who engage in transactions with Manchester Artists Association are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Manchester Artists Association collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Manchester Artists Association. Manchester Artists Association does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

Manchester Artists Association may collect statistics about the behavior of visitors to its websites. Manchester Artists Association may display this information publicly or provide it to others. However, Manchester Artists Association does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Manchester Artists Association discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to

know that information in order to process it on Manchester Artists Associations behalf or to provide services available at Manchester Artists Associations websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Manchester Artists Associations websites, you consent to the transfer of such information to them. Manchester Artists Association will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Manchester Artists Association discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when Manchester Artists Association believes in good faith that disclosure is reasonably necessary to protect the property or rights of Manchester Artists Association, third parties or the public at large. If you are a registered user of an Manchester Artists Association website and have supplied your email address, Manchester Artists Association may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Manchester Artists Association and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Manchester Artists Association takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Manchester Artists Association uses cookies to help Manchester Artists Association identify and track visitors, their usage of Manchester Artists Association website, and their website access preferences. Manchester Artists Association visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Manchester Artists Associations websites, with the drawback that certain features of Manchester Artists Associations websites may not function properly without the aid of cookies.

Business Transfers

If Manchester Artists Association, or substantially all of its assets, were acquired, or in the unlikely event that Manchester Artists Association goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Manchester Artists Association may continue to use your personal information as set forth in this policy.

Ads

Ads appearing on any of our websites may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by Manchester Artists Association and does not cover the use of cookies by any advertisers.
