### SCHOOL'S ARTS PROGRAM DESCRIPTION

Our school offers a challenging arts program to students in grades 6-12. Students in all grades receive the opportunity for arts instruction in instrumental music, theater arts, animation and/or visual arts. Students in grades 6 and 7 take one semester of each arts course before settling on an area of focus for 8th grade which will expose them to all of the art forms. High school students are provided with a choice regarding their arts program and are able to choose from a variety of disciplines. Within their major, students dive deep into different forms of coursework and are expected to be a part of our school's performances, concerts, gallery exhibitions, and arts-based internships. Partnerships with BRIC, NYU Steinhardt, Little Kids Rock and NURTUREart provide students with professional arts opportunities.




#### SCHOOL PROGRESS IN MEETING NEW YORK STATE EDUCATION REQUIREMENTS



**Middle School Arts Participation:** The figure below shows the percentage of students participating in arts classes by grade and by arts discipline during the 2018-19 school year.




**High School Arts Participation:** The figure below shows the percentage of students participating in arts classes by grade and by arts discipline during the 2018-19 school year.
