SCHOOL'S ARTS PROGRAM DESCRIPTION

All students in Middle School 319 received both music and theater education this year. In addition, the school ran a weekly afterschool choir and theater program. Through the Arts for Multilingual Learners (MLL) Grant, we partnered with Dancewave to provide six weeks of dance classes for one hundred fifty students, predominantly MLL and Students with Disabilities (SWD). Students learned a broad range of basic dance styles and did a small in-school performance. In the 2023-24 school year, Middle School 319 plans to present a full musical, continue the partnership with Dancewave to provide students with further dance instruction, and add instruction in visual arts.

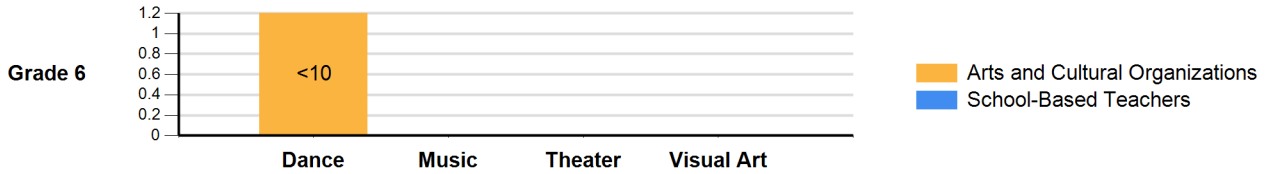

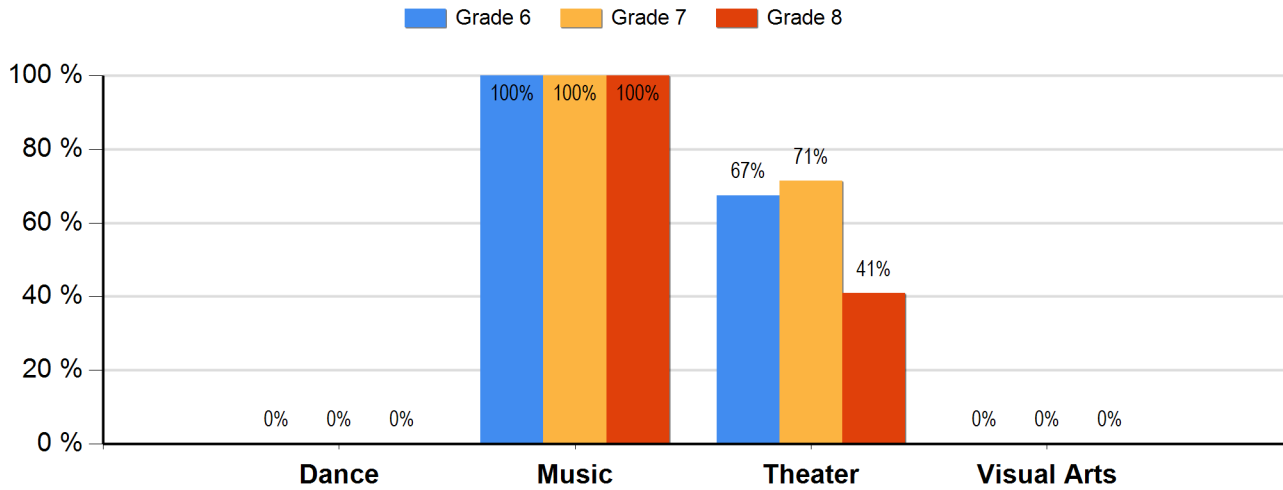
SCHOOL PROGRESS IN MEETING NEW YORK STATE EDUCATION REQUIREMENTS

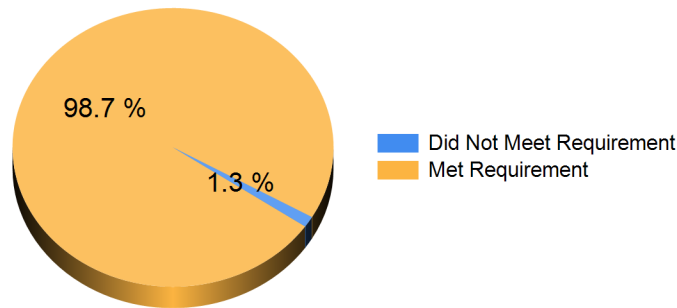
† "School-based teacher" may include: classroom teachers, certified specialists, or cluster teachers not certified in the arts who are assigned to provide arts instruction.

NYSED Middle School Arts Guidelines and Requirements: This graph shows the percentage of 8th grade students in this school in June 2023 who have taken at least one half-unit in an arts discipline and a second half-unit in a different arts discipline over the course of 7th and 8th grade (one half-unit is the equivalent of approximately 55 hours of instruction by a licensed, certified arts teacher).
