SCHOOL'S ARTS PROGRAM DESCRIPTION

Students in Pre-K through grade eight shall receive instruction that is aligned with the New York State Learning Standards for the Arts in dance, and the New York City Department of Education Blueprint for Teaching and Learning in the Arts. Students in Kindergarten through eighth grade receive arts instruction by two licensed dance teachers who integrate the visual arts into their dance projects, presentations and cultural performances. Students in Kindergarten, first grade and fifth grade received instruction and performance experiences with Dancing Classrooms. Students in grade four through eight received an afterschool residency with Ballet Hispanico, which provided in-school dance instruction and a final school performance for students and parents.




