

SCHOOL'S ARTS PROGRAM DESCRIPTION


Veritas Academy offers required visual arts classes and electives, rotating through drawing, studio art, illustration, painting, sculpture, art history and mixed media. All of these classes incorporate the NYCDOE Blueprint for Teaching and Learning in the Arts benchmark standards and the NYS standards for the visual arts. In addition to these classes, the technology department offers digital art and animation classes. Veritas offers trips to museums, Broadway shows and other theatrical and musical events. Participation in these events is based on voluntary participation. We try to involve as many students as possible in these events.

SCHOOL PROGRESS IN MEETING NEW YORK STATE EDUCATION REQUIREMENTS


High School Arts Participation: The figure below shows the percentage of students participating in arts classes by grade and by arts discipline during the 2022-23 school year.
