SCHOOL'S ARTS PROGRAM DESCRIPTION

Our school offers three school-based arts programs that occur during the regular school day. The visual and media arts programs are taught by Department of Education teachers. Media arts is provided to all sixth graders. Visual arts instruction is given in the seventh grade. These programs are offered daily. The school has recently partnered with a music instructor who visits the school twice a week and offers instruction on the use of percussion instruments. 




