SCHOOL'S ARTS PROGRAM DESCRIPTION

This year students in grades 6-8 were programmed for both visual arts and music instruction. Each class is programmed for two periods of visual arts and music instruction weekly. In the visual arts class, students developed many forms of visual arts, culminating in a visual arts portfolio. In the music classroom, students had access to shared string instruments. They were tasked with cleaning their instruments thoroughly and many held an instrument for the first time. In the 2023-2024 school year, we look forward to once again visiting local art museums and exhibitions. In addition to continuing our partnership with organizations such as Materials for the Arts, students will attend an open rehearsal of a professional music ensemble, such as The NY Philharmonic.









