Paul Lawrence is the senior litigation partner at Pacifica Law Group. He concentrates his practice on complex appellate and civil litigation, including commercial, municipal, constitutional, environmental, and insurance coverage cases in federal and state courts.

Paul's appellate experience includes over 125 appeals, principally in the Ninth Circuit Court of Appeals, the Supreme Courts of Washington and Montana, and the various Courts of Appeal in Washington. He has also practiced in the United States Supreme Court, the Second, Third, Seventh, Eleventh, D.C., and Federal Circuit Courts of Appeal, and the California and New York appellate courts. His appellate clients include a variety of public and private entities, whom he has represented in a broad range of cases, including many of first impression.

Paul has been lead trial counsel in numerous successful, complex, multi-party cases—including jury trials—in federal and state courts in Washington, Montana, and California. Recent experiences include obtaining a defense verdict in a breach of contract jury trial in Washington State Court. The verdict was upheld on appeal and his client was awarded its complete attorney's fees and costs. He also recently represented a large railroad company in two federal court bench trials.

Paul is one of the leading lawyers in Washington litigating and advising on both federal and state constitutional law issues. Issues include the First Amendment, the Equal Protection Clause, the Commerce Clause, and limitations on the scope of state and local legislative power under the Washington Constitution.

Paul also has an active ethics practice. He has advised entities such as the Ninth Circuit Court of Appeals, the Port of Seattle, Sound Transit, and Clark County, as well as individuals including sitting state court judges.

Paul is recognized on numerous top lawyer lists. Chambers and Partners USA has for several years ranked Paul as a commercial litigator. Representative Matters:

- Washington State Legislators and Education Advocates: Successful challenge to the Constitutionality of the 2/3rds Vote Initiative.
- Pike Place Market Development Agency: Defended the Pike Place Market against efforts of the Urban Group to wrest control of the market from the public.
